The APA citation style (6th Edition) is a parenthetical author-date style, so you need to put the author's last name and the publishing date into parentheses wherever another source is used in the narrative. The APA format consists of in-text citations and a reference list, along with guidelines for formatting the paper itself.

The sixth edition provides explicit rules for direct quotations and states that you must credit the source when “paraphrasing, quoting an author directly, or describing an idea that influenced your work” (p. 170). If the quotation is less than 40 words, incorporate the quotation into the text and place quotation marks round the quotation.

The 6th edition of the APA manual requires you to include the publisher's location when you cite from a print book. The city and state should be included for US-based publishers, the city and country for publishers anywhere else. If you are following the 7th edition, just write the name of the publisher – no location information is required.

Include any edition information in parentheses after the title, without italics. If the book includes a DOI, include the DOI in the reference after the publisher name. Do not include the publisher location. If the book does not have a DOI and is an ebook from an academic research database, end the book reference after the publisher name.

To cite a chapter in a book in a reference entry in APA style 6th edition include the following elements: Author(s) of the chapter: Give the last name and initials (e. g. Watson, J. D.) of up to

seven authors with the last name preceded by an ampersand (&). For eight or more authors include the first six names followed by an ellipsis (...) and add the last author's name.

The 7th edition of APA does not differentiate between the format of the books, print or electronic. Cite both the same way. If you have an open-access eBook, you may provide the URL at the end, provided it directly takes you to the full text without logging in.
