During the study period, 1515 women met the inclusion criteria. The majority of women (67%) delivered vaginally, after up to 10 hours in the second stage of labour. The overall rate of Caesarean section was low (15.7%). The rate of permanent neurologic impairment was 2.6 per 1000 deliveries.

Pregnancy outcome was known for 25 of the 29 cases. Only two fetuses, both with abnormal karyotype (monosomy X and trisomy 21), were liveborn at term. 11 pregnancies were electively terminated while the remaining 12 cases resulted in spontaneous pregnancy loss. 21 fetuses underwent necropsy which confirmed the prenatal ultrasound findings in most cases.
